Afghan Women's Situation: Allegations of Crimes Against Humanity and Gender-Based Discrimination, and the Path to Hold Taliban Accountable

#### INTRODUCTION:

The International Organization for Transitional Justice and Peace (ITJP) wants to host an online discussion on "Assessing the Situation of Afghan Women: Allegations of Crimes Against Humanity and Gender-Based Discrimination, and a Pathway to Hold the Taliban Accountable." This comprehensive discussion seeks to analyze and evaluate Taliban decrees, especially those against girls' education rights and women's rights to education and employment, in the context of crimes against humanity defined in the Rome Statute and international laws.

The objective of this responsible discussion is to seek and lay the legal grounds for holding the Taliban, particularly Haibatullah Akhundzada, the Taliban leader, and other officials directly supporting the prohibition of women's education and employment, accountable in international criminal courts and other responsible international bodies. Additionally, we will discuss UN commitments and national governments' and international criminal court mechanisms in bringing individuals involved in crimes against humanity and those openly supporting such actions to justice.

Furthermore, this discussion addresses procedural mechanisms available to the International Criminal Court for expeditiously addressing potential crimes against humanity in Afghanistan, assessing the court's capabilities, addressing Taliban illegitimacy and non-cooperation, and holding the Taliban accountable for committing crimes against humanity and gender-based discrimination.

Through this pragmatic and responsible discussion, we anticipate overcoming any hurdles to practical judicial actions by the ICC and other responsible entities. We seek effective collaboration with the ICC to ensure and expedite accountability for the Taliban.

## **BACKGROUND:**

Following the fall of Afghanistan, Haibatullah Akhundzada, the Taliban leader, and their ministries and subordinates issued several decrees, directives, and orders regarding Afghan women that completely banned their fundamental rights. Some of Haibatullah Akhundzada's decrees were

published by the Taliban Ministry of Justice in Official Gazette No. 1432, dated May 9, 2023. These orders include prohibiting Afghan women from education, employment, freedom of movement, freedom of expression and music, creating restrictions on accessing essential services and healthcare, preventing the right to protest, and engaging in cultural activities such as participating in public gatherings, sports programs, and travel. Overall, these decrees have suppressed women, deprived them of all rights, freedoms, and independence, placing them under complete male dominance and confinement.

However, the most concerning anti-women decrees issued by the Taliban to date include the closure of schools above the sixth grade for girls, banning women from attending universities, and prohibiting women's employment in government and non-governmental entities, including UN agencies.

On September 17, 2021, the Taliban issued an order prohibiting girls' education beyond the sixth grade in Afghanistan. Furthermore, additional orders were imposed on December 5 and 7, 2022, which prevented women and girls from continuing their education in universities and private courses until further notice. Additionally, on December 11, 2022, they officially prohibited women's employment in domestic and international non-governmental organizations. This restriction was later expanded in April 2023, and female United Nations personnel in Afghanistan were also banned from working in UN agencies.
